### Warranty Terms

1. The warranty will only be valid if the duly completed and signed warranty card is presented with proof of purchase for the product in question consisting of an original sales receipt or some other form of proof of purchase bearing the name of the Bulthaup authorized dealer and the product name. Furthermore, the warranty is only applicable for the final customer entered on the warranty card and is not transferable. Bulthaup reserves the right to refuse warranty performance if the aforementioned information was modified or amended after the purchase of the product.

2. During the warranty period Bulthaup undertakes to repair a defective product (part) or - at Bulthaup's option and discretion - to replace the product (part) with a similar or comparable product (part) provided (a.) the defect is a defect caused by Bulthaup in production or finishing (b.) and consequently is not a defect that became apparent or was caused by circumstances and/or conduct listed in section 7 of these warranty terms, (c.) the defect was reported immediately it was detected and (d.) nothing else results from the following provisions.

3. Repaired or replaced products may contain new and/or reconditioned/improved components and component groups. Repairs or a direct replacement under the terms of this warranty may therefore be effected using functionally equivalent replacement units, in particular for a part of a collective unit (e.g. veneer or stainless steel front) even if this might result in slight color variations within the same shade of color or similar adverse optical effect. Any parts replaced will become the property of Bulthaup. If Bulthaup no lol er sel, the product it will offer a suitable substitute product. there necessar approfinancial compensation may be paid.

4. Warranty repairs and lacement working stable by an stallation technician authorized (Bulthaup, lost for wark ity repairs an replace ment work that are not performed by ar instantion technician autherized by Bulthaup will not be reim, irsea, and the warranty will no extended any repairs, replacement work a dama with imagine ult from such repair work.

5. This warranty does not cover work performed under the warranty or product (parts) replaced in such a use. Furthermore, a repair or the replacement of a product (product parts) under the warranty does not justify extension or recommencement of the warranty period.

6. The warranty does not cover used products or (a.) when faults other than defects caused by Bulthaup in production or finishing are detected, (b.) when the product concerned is not a product manufactured by Bulthaup but by another manufacturer even if it was sold in combination with an original bulthaup product (e.g. accessories, kitchen appliances etc.), or (c.) when the product concerned is an article made of glass or china or is a consumable article (such as such as light bulbs, filter inserts, batteries, seals etc.).

7. Finally, the following points are also not covered by the warranty: (a.) normal wear and tear, especially as a result of natural use; (b.) physical properties or characteristics of the materials such as those of natural products, wood, wooden materials, aluminum products etc.; (c.) regular inspection/service, maintenance, repair or replacement work resulting from normal wear and tear: (d.) misuse, improper use, force used on or improper treatment of the product including – but not exclusively limited to – failure to use the product for its normal purpose or in accordance with the instructions for use and care (e.g. failure to heed the instructions for use and care, lack of care); (e.) use of the product in combination with accessories that have not been approved for use with this product; (f.) accidents, force majeure or circumstances beyond Bulthaup's control such as lightning strike, water, fire, disturbance or insufficient ventilation; (g.) exposure of the product to liquids and moisture that goes beyond normal use as well as exposure of the product to chemicals of any kind and/or high temperatures (in particular through intense warming of the rooms and through other climate related environmental, temperature or weather effects); (h.) faulty assembly/installation of the product or use of the same in contravention of the technical and safety standards applicable at the time of the contract of sale or at the current time; (i.) unapproved

modifications to the product as well as modifications, repairs (e.g. deinstallation of the product) or replacement work that was not performed by an installation technician authorized by Bulthaup.

No other rights and claims than those specified above are granted. In particular this warranty does not allow for any claims for compensation for accessory and consequential damage or for damages for the infringement of any legal or contractual warranty obligation for this product. Instead, it only allows for claims for repair or - at Bulthaup's option and discretion - for replacement of product (parts) affected by defects caused by bulthaup in production or finishing with a similar or comparable product in accordance with the aforementioned conditions during the warranty period. Bulthaup will not be liable for financial losses, downtimes, hired or rented equipment, travel costs, lost profit or similar due to products covered by the warranty or appliances outside of the warranty. Bulthaup's liability is limited to the purchase price of the product.
